

Terms & Condition (T&C)
RHB Ride for Good

1. RHB Ride for Good (the "Event") is organised by RHB Bank Berhad ("the Organiser"). World Endurance Malaysia Sdn Bhd has been appointed as the Technical & Registration Manager for this Event.
2. A rider, being a person who has entered to take part in the Event, is deemed to have given written permission to the Organiser for the Organiser to collect, analyse and collate the personal information relating to that rider. By completing the official entry form, including through online registration, the rider signals his / her agreement to abide by these T&C.
3. The rider agrees that by providing the personal information, the rider consents to the Organiser processing their personal information for any and/or all of the following purposes ("Purpose"), when/if applicable:
 - administering this Event and contacting the rider in relation to the same;
 - cross-selling, marketing and promotions of products and/or services of the Organiser's Group of Companies and its strategic alliances; and/or
 - other related and legitimate business purposes;
4. The rider agrees that the rider personal information may be disclosed to other companies within the Organiser Group of Companies (which shall include its holding company, subsidiary(s), and any associated company(s), including any company as a result of any restructuring, merger, sale or acquisition), service providers, and vendors and any of their respective agents, servants and/or such persons, whether located within or outside Malaysia for the Purpose, if applicable, subject at all times to any laws (including regulations, standards, guidelines and/or obligations) applicable to the Organiser.
5. The rider agrees that it is necessary for the Organiser to process the rider's personal information for the Purpose, without which the rider will not be able to participate in this Event. The rider may exercise their options in respect of receiving marketing materials (including cross-selling, marketing and promotions as described above) by contacting the Organiser through the Contact Details stated below.
6. Photographs/images, motion pictures, recording or any other record of the rider in the Event may be captured and may be used for the Organiser's publications, any commercial advertising or other promotional purposes, where applicable.

8. The rider agrees:
 - a. to provide true, accurate, current and complete information about the rider captured in the registration form (the "Registration Data");
 - b. to maintain the security of the rider's password and identification; and
 - c. maintain and promptly update the Registration Data to ensure that it is true, accurate, current and complete.
 - d. that any notices which are sent to the rider's email address registered with the Organiser shall be deemed as received by the rider provided that the Organiser/sender does not receive any delivery failure notification.
9. This event is free of charge. Registration and participation in the Event is strictly non-transferable.
10. The Organiser reserves the right to modify or substitute any of these T&C from time to time. If there is ambiguity in any of these provisions, the Organiser shall be the sole

authority to interpret and in so doing, it may take into account the interests of all affected riders.

11. The Organiser reserves the right to cancel the Event at any time without prior notice to riders, in which case the Organiser will make the effort to inform riders prior to the date of the Event. The Organiser shall not be liable for any consequential loss or inconvenience caused.
12. For any registration on behalf of any participant the principal member or the online user account owner shall be fully responsible to inform each member of the T&C of the Event and is deemed to have obtained each member participant's approval to accept the T&C on their behalf. Each member participant who has authorised this online registration by their friend is also deemed to have read and accepted the Event T&Cs.
13. **Riders' Entitlements**
 - a. All riders who successfully registered to this event will be issued an e-Bib.
 - b. Top five (5) prizes will be awarded to the top five (5) riders with the most accumulated distance.
 - c. Lucky draw prizes will be awarded to one hundred (100) lucky draw winners.
14. **Winners and Prizes**
 - a. Prizes will be awarded in non-monetary terms.
 - b. The Organiser reserves the right to replace any winners if he / she is found to be disqualified.
 - c. Collection of Prizes
 - i. The top five (5) and one hundred (100) lucky draw winners will be announced one week from the last day of submission date.
 - ii. The winners will be informed via email by the Organiser.
 - iii. The prizes need to be self-collected by winners or the winners' authorised person(s) at the RHB Bank Berhad's Ground Floor, Head Office in Jalan Tun Razak.
 - iv. For winners located outside of the Klang Valley, a separate arrangement will be made with the winners.
 - v. All winners or the winners' authorised person(s) must present their original identification document, such as identity card/ passport and/or authorisation letter to collect their prize.
 - vi. All prizes not claimed within two (2) weeks from the announcement of winners will be forfeited and the Organiser will be at liberty to redistribute or dispose of these proceeds as it sees fit.
 - vii. Prizes must be taken, in the form as presented by the Organiser. They are not transferable or exchangeable and are subject to the T&C as determined by the Organiser.
 - d. All prize winners or potential prize winners who wish to appeal or dispute results must make such appeals in writing to the Organiser. Appeals must be submitted to the Organiser within 24 hours after announcement of results. Failing to do so, the Organiser reserves the right not to entertain any disputes or appeal thereafter.
15. **Ride Regulations**
 - a. This is virtual riding event; you may cycle anywhere and at any time during the Riding Period.
 - b. Only riders who reside in Malaysia are eligible to participate in the Event.
 - c. Registration is open from 25 August 2021 – 17 September 2021.
 - d. Riders will be given a duration of two (2) weeks to complete their ride, from 18 September 2021 until 3 October 2021 ("Riding Period").
 - e. There are no limitations on the cycling distance as long as the rides are completed within the Riding Period, subject to the following:

- i. submission on distance cycled must be submitted to the Organiser on the same day as the riding day.
- ii. each rider is allowed to submit ONLY one (1) distance cycled per day.
- iii. All submission of riding distance must be done via Strava.
- f. Submission of cycling distance will be closed at 11.59pm on 3 October 2021. Organiser will then collate the riding distance accumulated by each rider and will publish, display or post the total distance cycled on a daily basis on the Strava app.
- g. For the purpose of the Organiser's charity pledge, the Organiser will pledge RM1 for every 1km cycled (1KM = 1RM) subject to a maximum of 100km (equivalent to RM100.00) per rider.
- h. All riders riding outdoor must strictly comply and abide by the standard Highway Code, national rules of the road, the current Covid-19 Standard Operating Procedures (SOP) imposed by the authorities at the time of the ride and any other applicable road rules & regulations (please refer to <https://www.kbs.gov.my/sop-sukan-rekreasi.html> & <https://pelanpemulihannegara.gov.my/index.html>)
- i. Riders are allowed to cycle using a bike trainer (Zwift) or an outdoor bicycle meant for outdoor riding.
- j. For outdoor riding, riders MUST NOT:
 - i. Ride without a protective riding helmet; and
 - ii. Ride dangerously or negligently;
- k. For outdoor riding, the following bikes are STRICTLY NOT ALLOWED:
 - i. Motorized Bikes
 - ii. Electric Scooters
 - iii. Unicycles
 - iv. Any motorized or engine powered vehicles

16. Safety Measures

- a. Riders participating in the Event are advised to practice safe cycling, and their participation is at their own risk. The Organiser will not be responsible or held liable for any losses, bodily injuries, deaths, damages or destruction to properties howsoever arising (including from training for or from participating in the Event) whether suffered by the riders or caused by the riders.
- b. The Organiser will not be liable for the actions of riders or other third parties, not employed by the Organiser or acting on its behalf.
- c. Riders are strongly encouraged to consult their medical practitioner prior to registration and before riding day.

17. Waiver Event

In consideration of the Organiser accepting this entry, and the registration to participate in the Event, the rider hereby waive and release any and all rights to claims for damages that the rider may have against the Organiser for holding this Event, their agents, representatives, successors, assigns, sponsors (if any) for any and all bodily injuries, deaths and damages that the rider may sustain before, during or after the course of the Event or arising as a result of it. The rider hereby indemnifies the Organiser and keep them indemnified and waived against all claims or damages that arise in consequence of the above.
