

RULES & REGULATIONS

1. IJM Allianz Duo Highway Run 2021 ('Event') is organised by EC PIXELS ('the Organiser').
2. This Event is open to all residing in Malaysia.
3. Participants shall agree to participate this Event at his/her own free will.
4. Participants shall abide by the Event Terms & Conditions set forth by the Organiser.
5. Participants confirmed that all information submitted during registration is complete and accurate.
6. Participants below age 18 must obtain consent from their parents/guardian before signing up for the Event.
7. Participants must deem fit to participate in this Event. The Organiser shall not be liable for any accident or mishap which arises as a result of non-disclosure of medical conditions by the participants.
8. Once the participant's registration has been duly processed, there will be NO refund for participants who do not eventually take part in the Event for whatever reason.
9. Participants must complete their course in one go. No accumulation of distance allowed.
10. Participants are required to submit their results via website/email.
11. The Organiser reserves the right to limit, accept or reject any entries without prior notice and reasons.
12. By signing up and providing any information, personal or otherwise, in order to gain access to and to participate in the Event or any activity(ies) relating to the Event, the participant is deemed to have given expressed permission to the Organiser, Event Manager and the Event Sponsors to use such personal information for marketing, statistical and planning purposes.
13. The Organiser reserves the right to modify or substitute any of these Rules & Regulations at any time, at its sole discretion, without prior notice. Any notice sent to the email address provided by the participant during registration shall be deemed as received by the participants. If a participant provides any information that is untrue, inaccurate, not current or incomplete or the Organiser has grounds to suspect that such information is untrue, inaccurate, not current or incomplete, the Organiser may suspend or terminate the participant's registration. There will be no fee refund upon such suspension or termination of the participant's registration.
14. The Organiser reserves the right to modify or substitute any of these terms and conditions of the Event from time to time as it deems fit. If there is ambiguity in any of the provisions, the Organiser shall be the authority to interpret and in so doing, the Organiser will take into account the interests of all the affected participants.
15. The Organiser reserves the right to change the Event Date and/or time of the Event or cancel the Event at any time without prior notice to the participants, in which case the Organiser will make reasonable effort to inform the participants prior to the Event Date. If the Event has to be cancelled, there shall be no refund unless the Organiser deems fit to give a refund. If the event Date and/or time are changed, there shall be no fee refund to any participant who is unable to participate in the revised date and/or time unless the Organiser deems fit to give a refund. The Organiser shall not be liable for any loss or inconvenience caused.
16. All entitlement's colour, design and material are subject to change without notice.

The Organiser and Event's sponsors reserve the right to use any photographs (including those of participants), motion pictures, recordings, or any other media records of the Event, for any legitimate purpose as it deems appropriate, including but not limited to advertising and publicity purposes and also for the purposes of announcing the winners in all types of media. By registering for the Event, participants hereby consent to publication or display of their details, including personal details and photographs.

The Organiser shall not be responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction, unauthorized access to, or alteration of, user or member communications, or any problems or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of e-mail or players on account of technical problems or traffic congestion on the internet and/or the Event's Official Website.
19. All transactions are in Ringgit Malaysia (MYR).
20. **CATEGORY 3 - "MY WAY, MY FORTE"**
 - a. This is a fun run category that comes with a photo contest.
 - b. There are a total of 7 locations at selected townships by IJM Land (Penang, Kuala Lumpur, Puncak Alam, Seremban, Johor Bahru, Sandakan) available for Participants to select and run.
 - c. NO designated running routes for this category. Participants can choose their own route and location. Participants are encouraged to choose a route that is safe and has strong GPS signal.
 - d. Participants are advised to follow all applicable laws and Government guidelines for Covid-19 and generally use of safe pedestrian practices when on the roads.

- e. Participants take part solely at their own risk and the Organiser and Sponsors will not be responsible or held liable for any injury, damage, death and other loss howsoever arising from participating in the Event.
